## Rules

### Rule 1 – Code of Conduct

- 1.1. Visiting Team Coaches must be advised of changes in location by the Home Team Coach no later than 3pm on gameday to ensure that affected players can also be notified.
- 1.2. **Players, Coaches, Referees, Parents, and Spectators are to demonstrate good behavior, follow the principles of fair play, respect for others & good sportsmanship**
- 1.3. Coaches, Managers, Team Officials, and Parents shall not criticize Game Officials at any time throughout the game and shall encourage the same attitude from the players and spectators. At this age division, our Referees and Assistant Referees are learning too.
- 1.4. Rivalry and antagonism between towns/clubs/teams is strictly forbidden. We need each other to have a successful and enjoyable recreational league.
- 1.5. Zero Tolerance Policy – Alcohol & Drugs:
  - ICSL has a zero-tolerance policy regarding alcohol or drugs at games. This encompasses coaches, players and parents/spectators.
  - No alcohol or drugs are permitted at the soccer fields before, during, or after ICSL scheduled games.
  - Smoking and vaping of any kind in the playing area, bench area, and spectator area is prohibited. Coaches are to ask their spectators to leave the park if they wish to smoke during a game or a practice.
  - Violation of this policy will be met with disciplinary action from the League, as well as its affiliates (Club, District, Ontario Soccer, Town/City, and Police).

### Rule 2 – Injuries

- 2.1. Blood:
  - Any player that bleeding or has blood on them must leave the field of play.
  - The player may only re-enter on receiving a signal from the referee, who must be satisfied that the bleeding has stopped and there is no blood on the equipment
- 2.2. Concussions:
  - The league recommends that teams/coaches follow the, “When in doubt sit them out,” rule when dealing with concussions and/or any injury to the head/neck.
  - Clubs are to follow their set protocols and guidelines & resources as outlined by Rowan’s Law and Ontario Soccer.

## Rule 3 – Coaching Standards

- 3.1. Coaching Standards– CSA Club Certification Standard
  - The League strongly recommends that all coaches should have CSA Grassroots Coach Education and Respect In Sport Activity Leader certifications. Both are part of the CSA Quality Soccer Provider Standard.
  - When dealing with contentious issues, Coaches should exercise the “24 hr. cooling off period” before sending an incident report or a complaint to the Division Convener or Club Representative.
- 3.2. Coaches are responsible for the conduct of their bench and spectators. If there is a problem with spectators, the Coach of the spectator’s team will deal with that person. If the spectator is not part of either team, the Home Coach is responsible for dealing with that person. The game will be stopped and the time will remain running until the issue has been resolved (Refer to Rule 4 – Take 5).
- 3.3. Coaches are responsible for reviewing and understanding the Inter-County Soccer League Manual and must sign the acknowledgement form, available as the last page of the Manual.

## Rule 4 – Heading

As per Ontario Soccer’s Heading Guidelines, heading is allowed in games, however, it is not encouraged.

## Rule 5- Take 5

- 5.1. Spectators will have no interactions, of a conflicting nature, with game officials before, during and after games.
- 5.2. Take 5 is an initiative to specifically address spectator behaviour, that goes beyond being acceptable, immediately in the moment
- 5.3. The approach involves a total of 3 Stages:
  - Warning
  - Timeout
  - Abandon
- 5.4. The following are examples of unacceptable behaviours (this is not an exhaustive list):
  - Sarcastic clapping
  - Attempts to intimidate the referee
  - Name calling
  - Dissenting and rude comments
  - The use of foul language
  - Any attempts to enter the field of play to confront a Match Official
  - Other actions deemed inappropriate by the Match Official

### 5.5. How it works:

#### **Step 1 – Warning**

- The first time that spectator behaviour crosses the acceptable threshold, the referee will pause the game
- The referee will address the behaviour with the coaches, who will then address their team's spectators
- No additional time is added for the warning stoppage (that is, the time keeps running)
- Play is restarted accordingly

#### **Step 2 – Timeout**

- The second time spectator behaviour crosses the acceptable threshold, the game is paused for five minutes
- No additional time is added for this stoppage (that is, the time keeps running)
- No activity is allowed on the field during this time
- Once the 5 minutes have elapsed, play is restarted accordingly

#### **Step 3 – Abandon**

- The third time spectator behaviour crosses the acceptable threshold, the game is abandoned
- The referee will submit a report to their Club Head Referee detailing the incident
- The Club Head Referee will inform both team's ICSL Club Representatives and the ICSL President for disciplinary review

5.6. If unable to get the parent/spectator off the field/park, the game will be canceled. The League will consider the case before deciding on a reschedule or forfeiture.

5.7. The Referee will file a report to their Club Head Referee & their Club Representative.

## **Rule 6 – The Field of Play**

6.1. Refer to the chart below for field size. The touchline must be longer than the goal line.

6.2. Field of play must be properly marked with goal areas, halfway line, retreat line, centre mark, centre circle, goal lines, and touchlines.

- Note that for U8 soccer, there is goal area but no penalty area.
- Note that for U10 soccer, the goal area is the same as the penalty area.
- Note that for U8 soccer the retreat line is the same as the halfway line.

6.3. Goals are to be equal sized. Refer to the chart below for maximum goal size. The goal posts must be white and must not be dangerous. All goals (including portable goals) must be firmly secured to the ground. Goal nets must be installed.

6.4. Corner flags are recommended. Corner flag posts must not be less than 1.5m (5ft) high, with a non-pointed top. If corner flags are not available, appropriate (safe) pylons may be used.

6.5. Fields must be clean and appropriate for playing.



- 6.6. Home clubs are responsible for provisioning a suitable field of play as defined above
- 6.7. Spectators are to be a minimum of 1m back from the touchline, on the OPPOSITE side of the field from the team benches. Spectators are not to be behind the goal lines.
- 6.8. Fields that are in poor condition should be reported to the division convener immediately following the game.

## Rule 7 – Team-Player Bench

- 7.1. Coaches, bench staff, and team players must locate themselves on the OPPOSITE side of the field from the spectators during all games.
- 7.2. Only registered team officials (coaches, trainers, managers) are eligible to be on the team bench. Exception made for club president and technical director
- 7.3. A maximum of three (3) team officials are permitted at the bench.
- 7.4. Team Officials will coach within two (2) meters of their bench and are not permitted to walk up and down the touchline.
- 7.5. Spectators shall not be allowed in or around the bench area or at the ends of the field.
- 7.6. Club/Team officials shall be responsible for the conduct of their spectators and ensuring that the above rules are followed.

## Rule 8 – The Ball

- 8.1. The Home Team shall supply two (2) regulation game balls, in good condition, to the referee prior to the start of the match.

## Rule 9 – The Players

- 9.1. All teams and players must be registered with the Ontario Soccer Association through their local district and all applicable registration fees paid before participating in Inter-County Soccer League practices or games.
- 9.2. Each player that dresses for the game must play 50% of the game unless prevented by injury or illness (Note: this rule will be enforced by the Coach, not the Referee).
- 9.3. Half of the boys or girls that are present at a game, must be on the field at any time, while promoting equal playing time for all. (Note: this rule will be enforced by the Coach, not the Referee).

- U8 example, if a team has four (4) girls and five (5) boys present at a game, then there must be a minimum two (2) girls on the field at all times.
- U10 example, if a team has five (5) girls and eight (8) boys present at a game, then there must be a minimum of two (2) girls on the field at all times

9.4. A match may not start or restart if either team has fewer than the “Minimum Players per Team for a Game” as noted in the chart

**9.5. Let Us Play rule:**

- When a team has less than the required number of players to start a game, players can be borrowed from the opposition so that a game may take place.
- This rule can also be implemented to assist a team with fewer players than the match format to allow both teams to achieve the match format.
- Players must agree to play on the other roster for the game.
- Rosters could also be completely mixed up to allow the players to play in a pressure free environment.

**9.6. 4 Up – 1 Up rule:**

- When the goal difference between two teams rises to 4 goals, the losing team has the option of adding a player to make the game more competitive and encourage a better learning environment for all involved.
- When the goal difference is reduced to 3 goals, the additional player is removed, such that both teams once again have the same number of players on the field.
- If the goal difference rises to 8 goals, a second additional player may be added.

9.7. If a team is a “no show”, the coach or manager of the team present is to report the situation to the Division Convener.

9.8. A player is not permitted to register for more than one (1) team in the Inter-County Soccer League.

9.9. Any player registered as a competitive (rep) level player in a different league is not permitted to play in the Inter-County Soccer League.

9.10. Players may be called up to a higher age division team within the following guidelines:

- The player must be registered to a recreational team in the same club, in the age division directly below the age group for which they are called up to play for.
- If the club does not have a division directly below the age group for which they are called up to play for, then the club can use a player from a division two (2) age groups below. Special consideration should be taken by the coach to ensure the player being called up is of adequate size and has a minimum skill level to ensure their safety.

- If a player is registered to two (2) teams in different clubs, they may not be used as call up in games against either club
  - Before a player may be called up, the coach **must** get permission from the player's parents and coach.
- 9.11. A team shall only have on the field of play no more than one (1) more player than the opposing team. Unless using the 4 Up 1 Up Rule (9.6).
- 9.12. During the game play, an unlimited number of player substitutions may be made, upon permission from the referee at any stoppage of play.
- 9.13. All substitutions are encouraged to enter the field at the half line after substituted players have left the field.

### Rule 10 – The Player's Equipment

#### 10.1. Safety

- A player must not use equipment or wear anything that is dangerous.
- All jewelry is to be removed; no taping of any kind is permitted. This includes all rings, earrings, piercings, necklaces and Fitbit-type watches or similar devices. The player must leave the field while removing jewelry. The Player is not allowed back on the field until the Referee has inspected the player to ensure compliance. A substitute shall NOT be allowed in this instance
- Exceptions:
  - Medic Alert bracelets and necklaces are allowed but must be taped such that they are fastened securely so as not to bring danger to any player. The taping should be such that the description of the medical problem is clearly visible.

#### 10.2. Colours

- Teams must wear matching uniforms (i.e., socks, shorts, and jersey) that distinguish them from each other and the match officials
- Each goalkeeper must wear colours that are distinguishable from the other players (of both teams) and the match officials
- Competing teams must wear uniforms of differing colours. The home team must arrange for alternate uniforms or pinnies if their uniform colours are considered by the referee to be too similar to the visitor's uniform colours.

#### 10.3. Compulsory Equipment

The compulsory equipment of a player comprises the following separate items:

- A shirt with sleeves
- Shorts
- Socks tall enough to fully cover the shin guards
- Shin guards – these must be made of a suitable material and be of an appropriate size to provide protection and be covered by the socks
- Appropriate footwear

### 10.4. Other Equipment

- Non-dangerous protective equipment, for example gloves, headgear, facemasks and knee and arm protectors made of soft, lightweight padded material is permitted
- Casts (hard plaster) are considered to pose a danger and are not permitted on the field of play.
- Any hard plastic or metal of braces (ex. Knee brace, elbow brace, wrist brace) need to be padded and covered.
- Any hair apparel must be of soft fabric.
- No plastic or metal items are to be worn.
- Goalkeepers' caps are permitted. No other player is permitted to wear a cap.
- Eyeglasses are permitted. Referees should show common sense and allow spectacles as long as they are not dangerous. Players may use sports spectacles but these are not necessary to play in Inter-County Soccer League
- Headscarves and turbans are permitted as long as they adhere to the following:
  - They must be safe and not pose a danger to the wearer or other participants.
  - They must not be attached to the jersey
  - They must not have any part(s) extending out from the surface (no protruding elements)
- Non-uniform clothing is allowed based on weather conditions, but uniforms must still be visible in order to distinguish teams
  - Non-uniform clothing must not pose a safety hazard (for example, hoodies are not permitted)

10.5. A player who is asked to leave the field of play because of defective or dangerous equipment may not re-enter the field of play until the referee is satisfied that the equipment is permissible. The equipment may only be inspected during a stoppage in play

10.6. Referees have the final say on the safety of all equipment.

## Rule 11 – The Referee

### 11.1. The authority of the referee

- Each match is controlled by a referee who has full authority to enforce the Laws of the Small-Sided Game in connection with the match.

### 11.2. Decisions of the referee

- Decisions will be made to the best of the referee's ability according to the Laws of the Game and the 'spirit of the game' and will be based on the opinion of the referee, who has the discretion to take appropriate action within the framework of the Laws of the Game.
- The decisions of the referee regarding facts connected with play, including whether or not a goal is scored and the result of the match, are final. The decisions of the referee, and all other match officials, must always be respected.

11.3. The referee acts as a timekeeper for the match.

11.4. The referee has discretion to stop, suspend, or abandon the match for any infringements of the Laws.

- 11.5. The referee takes action against team officials who fail to conduct themselves in a responsible manner and may expel them from the field of play and its immediate surrounds
  - Small-sided referees should avoid the use of Yellow and Red Cards towards players
  - As needed, the referee may Warn, Caution (yellow card), or Send-off (red card) any Team Official
  - This includes any and all incidents that happen before, during, or after the match
  - The Referee will file a report to their Club Head Referee & their Club Representative
- 11.6. Even though scores are not recorded, it is recommended that the referee keep a tally of goals per team to assist in the implementation of the 4 down 1 up rule.
- 11.7. Referees and Game Officials will follow the Ontario Soccer Policy, Code of Ethics & Professional Conduct for Match Officials. This will include following the four ethical principles: Integrity, Competence, Respect, and Responsibility.
- 11.8. Any misconduct by a referee is to be reported to the Club Representative and Club Head Referee.
- 11.9. Referees should be a minimum Ontario Soccer Association (OSA) Small-Sided Level and a minimum two (2) years older than the age group of the teams they are officiating.
- 11.10. A Referee must be available to officiate each game, arranged for and compensated by the local soccer club, association or organization. Referee compensation will be set by the club in adherence to the chart below.

<b>Travel Compensation</b>	Visiting Refs (i.e. not regularly affiliated with the hosting club) shall be compensated for travel at the rate of \$15 for distances less than 30km total and \$30 for distances over 30km total travel.	

- 11.11. Spectators will have no interactions, of a conflicting nature, with game officials before, during and after games. Referees and Coaches shall follow these steps if an incident occurs on the field.
  - Referee will stop play. Play will remain stopped until the incident has been resolved
  - Referee will discuss the incident with the coach(es) and the action that is to be taken
  - Coach(es) will talk to parent/spectator to communicate a one time only warning or to communicate their removal from the field / park
  - If unable to get the parent/spectator off the field/park, the game will be canceled. The League will consider the case before deciding on a reschedule or forfeiture.
  - The Referee will file a report to their Club Head Referee & their Club Representative.
- 11.12. Failure of the Referee to attend a game for which they are scheduled is to be reported to the Club Representative and the Club Head Referee.

## Rule 12 – Duration of the Match

12.1.

- 12.2. Allowance for time lost is made in either period for time lost through assessment of injured players, removal of injured players from the field of play, wasting time, pre-determined water breaks, or any other cause. Time allowance for time lost is at the discretion of the Referee.
- 12.3. The referee will not compensate for a timekeeping error during the first half by increasing or reducing the length of the second half.
- 12.4. Kick off for games will occur at the scheduled time.
- 12.5. Cancelled games do NOT have to be rescheduled.
- 12.6. Games may be rescheduled by the mutual consent of the home team coach and the visiting team coach. Reasons for rescheduling may include weather, air quality, school trips and events or conflicts with other sporting events but all reschedules must be approved by the Division Convener and subject to the following guidelines:
- All regular rescheduling, with the exception of weather and air-quality cancellations, **must** be done at least seven (7) days prior to the game date. Reschedules with fewer than seven (7) days until the game may be considered by the Convenor on a case-by-case basis.
  - Cancellations of games by the League or referee just prior to or during the game can be rescheduled if agreed to by both coaches. The home coach must notify the Division Convener of the agreed upon rescheduled date within one week of the originally scheduled game date.
  - If both coaches cannot agree to a reschedule date, the game will not be played.
  - A new game date **must** be decided upon before the reschedule will be permitted.
  - A field and referee must be available **and** booked by the home team coach before the reschedule will be permitted.
- Note: Do not postpone the rescheduled game(s) to the end of the season since timing may not allow it to be played.
- 12.7. Only the referee can cancel play during the game or just prior to the start of the game. Reasons for cancellation can include lightning, heat, or air quality.
- Note: The Home Coach should notify the visiting coach of inclement weather or field closure no later than 5pm on game day.
- 12.8. For cancelled games, both coaches must arrange to reschedule a cancelled game within one week. The Division Convener must be notified by the home team coach.

12.9. If the coaches can not agree on a reschedule date (due to a reschedule request or cancellation) the game will not be played.

12.10. **Inclement Weather and Air Quality Policy:**

To ensure player safety teams will follow the direction of Game Officials regarding inclement weather and air quality. Game Officials will determine before the start of the game whether water breaks are necessary. Game Officials will also have final say whether the game should be canceled due to inclement weather or air quality as outlined by the criteria listed below.

- **Thunder and Lightning:**

- If you can hear thunder, you can get hit by lightning. As soon as you hear thunder, quickly get to a safe location. More people are struck before and after a thunderstorm than during one. Stay inside for 30 minutes after the last rumble of thunder.
- Get to a safe place. A safe location is a fully enclosed building with wiring and plumbing. Sheds, picnic shelters, tents or covered porches do NOT protect you from lightning. If no sturdy building is close by, get into a metal-roofed vehicle and close all the windows
- When considering resumption of any athletics activity, wait at least thirty (30) minutes after the last flash of lightning or sound of thunder before returning to the field.

- **WARNING LEVELS for Severe Weather:**

Environment Canada Range of Humidex & Temperature

**Caution:** mandatory water breaks when Humidex of 30-39°C and 28°-30°C Temp.

**Dangerous:** Cancellation of Game when Humidex of 40°C+ and 31°C+ Temp.

- **WARNING LEVELS for Air Quality:**

**Caution:** games will be played under a Caution if the expected air quality in a hosting town is as follows - Air Quality Index (AQI) between 5 and 6. Additional water breaks are mandatory and the game official may abandon a game early if the air quality becomes worse.

**Dangerous:** games are to be cancelled if the expected air quality in a hosting town is as follows - Air Quality Index (AQI) of 7 or higher.

## Rule 13 – The Start and Restart of Play

13.1. At the beginning of a game, a coin toss is held by the referee between a player of each team

- The team that wins the coin toss decides which goal it will attack in the first half or to take the kick-off

13.2. In the second half of the match:

- The teams change ends and attack the opposite goal
- The team that did not take the kick-off to start the match takes the kick-off to start the second half



### 13.3. Kick-Off

- A kick-off is a way of starting or restarting play:
  - At the start of a match
  - After a goal has been scored
  - At the start of the second half
  - At the start of each period of extra time, where applicable.
- A goal may be scored directly from a kick-off, but only against the opponents; if the ball directly enters the kicker's goal, a corner kick is awarded to the opponents.
- After a team scores a goal, the kick-off is taken by the other team
- All players, except the player taking the kick-off, must be in their own half of the field
- The opponents of the team taking the kick-off must be set back from the ball:
  - U8 must be 3 metres (3 yards) away from the ball until it is in play
  - U10 must be 5 metres (6 yards) away from the ball until it is in play
- The ball must be stationary on the centre mark
- The player taking the kick-off must wait until the referee gives the signal before playing the ball
- The ball is in play when it is kicked and clearly moves
- The kicker must not touch the ball again until it is touched by another player
- For any offenses listed below, the kick-off is retaken:
  - Players not in their own half of the field (except the player taking the kick-off)
  - Opponents encroaching on the ball
  - Ball not on the centre mark
  - Kick-off taken before referee's signal has been given
  - Kicker touches the ball a second time with their feet
- If the player taking the kick-off touches the ball with their hands after it has been kicked, an indirect free kick is awarded

### 13.4. Dropped-Ball

- A dropped ball is a method of restarting play when, while the ball is still in play, the referee is required to stop play temporarily for any reason not mentioned elsewhere in the Small Sided Laws of the Game. Some examples of this are an injury or interference by an outside agent
- The referee drops the ball for one player of the team that last touched the ball at the position where it last touched a player, an outside agent
- If, when play was stopped, the ball was in or last touched in the penalty area, the ball is dropped for the defending team goalkeeper in their penalty area
- All other players (of both teams) must remain at least 4 metres (4.5 yards) from the ball until it is in play



- The ball is in play when it touches the ground
- A goal CANNOT be scored directly from a dropped ball, the ball must be touched by at least 2 players before it enters the goal
- For any offenses listed below, the ball is dropped again:
  - Ball touches a player before it touches the ground
  - Ball leaves the field of play after it touches the ground, without touching a player
  - Ball leaves the field of play before it touches the ground
- If the ball enters the goal without touching at least 2 players, play is restarted as follows:
  - A goal kick if it enters the opponents' goal
  - A corner kick if it enters the team's goal

### Rule 14 – The Ball In Play and Out of Play

14.1. The ball is out of play when:

- It has wholly crossed the goal line or the touch line, on the ground or in the air
- Play has been stopped by the referee
- The ball touches the referee, remains on the field and:
  - A team starts a promising attack
  - The ball goes directly into the goal
  - The team in possession of the ball changes
  - Restart for all of these situations is a dropped ball

14.2. The ball is in play at all other times including rebounds off game officials (when they are on the field of play), goalposts, crossbars, or corner posts, which result in the ball remaining in the field of play.

### Rule 15 – Method of Scoring

15.1. No scores or standings will be kept

15.2. A goal is scored when the whole of the ball has crossed over the goal line between the goal posts and under the crossbar, provided that no infringement of the Laws of the Small Sided Game has been previously committed by the team scoring the goal

### Rule 16 – Offside

16.1. There is no offside in U8 or U10 soccer

### Rule 17 – The Pass-In or Dribble-In

17.1. A pass-in or dribble-in is a method of restarting play, and is awarded to the opponents of the player who last touched the ball when the whole of the ball passes the touch line, on the ground or in the air

- 17.2. A goal CANNOT be scored directly from a pass-in or dribble-in, the ball must be touched by at least 2 players before it enters the goal.
  - if the ball enters the opponents' goal – a goal kick is awarded
  - if the ball enters the thrower's goal – a corner kick is awarded
- 17.3. At the moment of delivering the ball, the kicker:
  - Is standing and facing the field of play at the point where the ball left the field of play,
  - Has part of the ball on or behind the touchline
  - Has the ball stationary
- 17.4. All opponents must stand at least 3 m (3 yards) from the point on the touchline where the pass-in/dribble-in is to be taken
- 17.5. The ball is in play when it is kicked and clearly moves
- 17.6. For any offence, the pass-in/dribble-in is retaken, unless that offence is a hand ball to which an indirect free kick is awarded

### Rule 18 – The Corner Kick

- 18.1. A corner kick is awarded when the whole of the ball passes over the goal line either on the ground or in the air, having last touched a player of the defending team, and a goal has not been scored
- 18.2. A goal may be scored directly from a corner kick, but only against the opposing team; if the ball directly enters the kicker's goal, a corner kick is awarded to the opponents
- 18.3. Corner Kicks are taken from the corner arc of the nearest flag post from where the ball went over-the goal line.
- 18.4. The ball must be stationary and is kicked by a player of the attacking team
- 18.5. The corner flag post cannot be moved or repositioned when taking a Corner Kick
- 18.6. The ball is in play when it is kicked and clearly moves; it does not need to leave the corner area
- 18.7. Opponents must remain at least 5m (6 yards) from the corner arc until the ball is in play
- 18.8. For any offences, including those listed below, the corner kick is retaken:
  - Opponents encroaching within 5m of the ball
  - Kicker touches the ball a second time with their feet
- 18.9. An indirect free kick is awarded to the opposing team if the kicker touches the ball a second time with their hands

### Rule 19 – The Goal Kick

- 19.1. A goal kick is awarded when the whole of the ball passes over the goal line either on the ground or in the air, having last touched a player of the attacking team, and a goal has not been scored
- 19.2. Goal kick may be taken from anywhere inside the penalty area, by any player of the defending team.
- 19.3. The ball must be stationary when the kick is taken.
- 19.4. All opponents must be behind the retreat line – refer to retreat line rules
- 19.5. The ball is in play when it is kicked and clearly moves

- 19.6. A goal can be scored directly from a goal kick, but only against the opposing team. If the ball directly enters the kicker's goal, a corner kick is awarded to the opponents.
- 19.7. For any offences, including those listed below, the goal kick is retaken:
- Opponents cross the retreat line before they are permitted
  - Kicker touches the ball a second time with their feet
  - The goalkeeper takes the goal kick and touches the ball a second time with their hands inside of the penalty area
- 19.8. An indirect free kick is awarded if the kicker touches the ball a second time with their hands, except for the goalkeeper inside their penalty area
- The indirect free kick is awarded to the opposing team from the position where the second touch occurred
  - If the second touch (with the hands) occurred in the penalty area, the ball is positioned for the kick on the penalty area line, parallel to the goal line, at the point nearest to where the offence occurred

### Rule 20 – The Retreat Line

- 20.1. The retreat line will come into play when the ball has gone out for a goal kick or when the goalkeeper has the ball in their hands.
- 20.2. The retreat line shall be marked at the halfway line for U8 and at 1/3 rds of the field for U10. The use of field markers outside the field of play to indicate the retreat line is recommended where a line is not painted on the field.
- 20.3. The ball is in play once-it is kicked and clearly moves. All opponents must be behind the retreat line and cannot cross the retreat line until the ball:
- Is touched by a player of the team releasing the ball or,
  - Leaves the field of play or,
  - Goes over the retreat line.

Note: If the goalkeeper or kicker chooses not to wait for the opposing players to "retreat" and releases the ball quickly, the opponents are permitted to challenge for the ball without going back to the retreat line.

### Rule 21 – Free Kicks

- 21.1. All free kicks are indirect, with the exception of penalty kicks in U10
- 21.2. All opponents must be at least 5m (6 yards) from the ball
- 21.3. The ball must be stationary when the kick is taken
- 21.4. The ball is in play when it is kicked and clearly moves
- 21.5. The kicker must not touch the ball again until it has been touched by another player

- 21.6. A goal can only be scored from an indirect free kick if the ball is touched by another player before it enters the goal
- If an indirect free kick is kicked directly into the opponent's goal, without being touched by a second player, a goal kick is awarded
  - If an indirect free kick is kicked directly into the team's own goal, without being touched by another player, a corner kick is awarded
- 21.7. Indirect free kick inside the penalty area
- For the defending team, the kick may be taken from any point inside the area
  - For the attacking team, the ball is positioned for the kick on the penalty area line, parallel to the goal line, at the point nearest to where the offence occurred
- 21.8. Indirect free kick outside the penalty area
- All free kicks outside of the penalty areas are to be taken from the place where the offence occurred except for:
    - Offences involving a player entering or leaving the field of play are taken from the position of the ball when the play was stopped
    - If a player commits an offence off the field of play, play is restarted with a free kick taken on the boundary line nearest to where the offence occurred
- 21.9. Where 3 or more defending players form a "wall", all attacking players must remaining at least 1m (1 yard) from the "wall" until the ball is in play
- 21.10. For any offences, including those listed below, the indirect free kick is retaken:
- Opponents encroaching within 5m of the ball
  - Kicker touches the ball a second time with their feet
- 21.11. An indirect free kick is awarded if the kicker touches the ball a second time with their hands. For U10, if the offence occurred inside the kicker's penalty area and the kicker was not the goalkeeper, a penalty kick is awarded

### Rule 22 – The Penalty Kick – U10 ONLY

- 22.1. A penalty kick is awarded if any of the offenses that results in a Direct Free Kick is committed by a player inside their own penalty area, irrespective of the position of the ball, provided it is in play.
- 22.2. The kick is taken from the penalty mark, which is 9m (10 yards) away from the back edge of the goal line.
- 22.3. The ball must be stationary
- 22.4. Player taking the penalty kick must be clearly identified
- 22.5. Defending goalkeeper:
- Must be on their goal line, facing the kicker, between the goal posts, without touching the goal posts, crossbar, or goal net, until the ball has been kicked

- When the ball is kicked, the goalkeeper must have at least part of one foot touching the goal line
- 22.6. Players other than the kicker and the defending goalkeeper must be located:
  - Inside the field of play
  - Outside of the penalty area
  - Behind the penalty mark
  - At least 5m (6 yards) from the ball
- 22.7. After the players have taken their positions as per the rules above, the referee signals for the penalty kick to be taken
- 22.8. The player taking the penalty kick must kick the ball forward
- 22.9. The kicker must not play the ball again until it has touched another player
- 22.10. The ball is in play when it is kicked and clearly moves
- 22.11. For any offence, refer to the chart below

## Rule 23 – Fouls and Misconducts

- 23.1. The referee shall attempt to explain ALL offences to the offending player
- 23.2. It is the decision of the Referee as to whether a foul or misconduct has occurred.
- 23.3. The following is a list of fouls:
  - A. Kicks or attempts to kick an opponent
  - B. Trips or attempts to trip an opponent
  - C. Jumps at an opponent
  - D. Charges an opponent
  - E. Strikes or attempts to strike an opponent (including head-butt)
  - F. Pushes an opponent
  - G. Tackles or challenges an opponent (note: slide tackles of a fair nature are allowed)
  - H. Throws an object at the ball, an opponent, or the referee, or makes contact with the ball with a held object
  - I. Holds an opponent
  - J. Impedes an opponent with contact
  - K. Bites or spits at someone on the team lists or the referee
  - L. Handball offence
  - M. Plays in a dangerous manner
  - N. Impedes the progress of an opponent without any contact being made
  - O. Prevents the goalkeeper from releasing the ball from their hands or kicks or attempts to kick the ball when the goalkeeper is in the process of releasing it
  - P. Is guilty of dissent, using offensive, insulting, or abusive language and/or action(s) or other verbal offences
- 23.4. For U10 only – if any of the fouls from A to L, listed above are committed inside the penalty area, a penalty kick is awarded

## Rule 24 – Disciplinary Action

- 24.1. Small Sided Referees should avoid the use of Yellow and Red cards towards players
- 24.2. As needed, the referee may Warn, Caution (yellow card), or send-off (red card) a Team Official
- 24.3. Warning – the following offences should usually result in a warning (repeated or blatant offences should result in a caution or sending-off):
  - Entering the field of play in a respectful / non-confrontational manner
  - Failing to cooperate with a match official (ex. Ignoring an instruction or request)
  - Minor / low-level disagreement (by word or action) with a decision
  - Occasionally leaving the confines of the technical area without committing another offence

- 24.4. Caution – caution offences include, but are not limited to:
- Clearly / persistently not respecting the confines of their team’s technical area
  - Delaying the restart of play by their team
  - Deliberately entering the technical area of the opposing team (non-confrontational)
  - Dissent by word or action including:
    - Throwing / kicking drink bottles or other objects
    - Actions which show a clear lack of respect for the referee (ex. sarcastic clapping)
  - Acting in a provocative or inflammatory manner
  - Persistent unacceptable behaviour (including repeated warning offences)
  - Showing a lack of respect for the game
- 24.5. Sending-Off – sending-off offences include, but are not limited to:
- Delaying the restart of play by the opposing team
  - Deliberately leaving the technical area to:
    - Show dissent towards, or remonstrate with, the referee
    - Act in a provocative or inflammatory manner
  - Entering the opposing technical area in an aggressive or confrontational manner
  - Deliberately throwing / kicking an object onto the field of play
  - Entering the field of play to:
    - Confront a match official (including at half time)
    - Interfere with play, an opposing player, or a match official
  - Physical or aggressive behaviour
  - Receiving a second caution in the same match
  - Using offensive, insulting, or abusive language and/or actions
  - Violent conduct
- 24.6. The referee will notify the Home Club’s Head Referee of any Yellow and/or Red Card infractions
- 24.7. The Division Convener will be notified of any Yellow and/or Red Card infractions by the Home Club’s Head Referee
- 24.8. For all youth competitions, a coach must be present in the Team’s technical area. If there is only one coach and they are sent-off, the referee must abandon the match.
- 24.9. Abandoned matches are to be reported to the Division Convener by both teams.

## Festivals

Inter-County Soccer Club aims to host 2 festivals per age division throughout the soccer season.

These festivals are meant to be fun for all of the players. No scores will be kept for any of the games. Players from multiple teams can join together to make one team.
